Sir / Madam,

In response to your advertisement in Loksatta dated 30.11.2024, you had applied for the post of Principal. You were interviewed for the above post by the Selection Committee appointed by the Management under Statute No.415 of the Savitribai Phule University of Pune.

I am pleased to inform you that you are appointed in the service of Maratha Vidya Prasarak Samaj, Nashik & Posted at Kar. P.G.Arts, Commerce & Science College, Igatpuri, Tal.Igatpuri, Dist.Nashik in the Scale of **Rs. 131400-217100 (S-13A)** per month, with effect from **17.04.2025** or the date of your report for duty. Your appointment is subject to the following terms & conditions.

1. Your service will be governed by the Maharashtra University Act-2016, Statutes, Code of conduct, Ordinances and rules regulations laid down by the Savitribai Phule University of Pune & State Government from time to time.
2. (a) You are appointed in clear vacancy on full time basis for a period of Five Years Tenure OR the date of retirement whichever is earlier form the date of Joining.
(b) As per UGC norms the post is "Tenure Post" of a tenure of five years.
(c) X Your appointment is on the leave vacancy for the period from --- to ----.
(d) The post is reserved for **Open to All** category. Since you belong to the **Said** category, you are appointed on full-time basis for a period of Five Years Tenure OR the date of retirement whichever is earlier form the date of Joining.
(e) X The post is reserved for ---- category. Since you do not belong to the said category, you are appointed full-time on temporary basis against the reserved post up to --. You shall not have any claim on the said post in future.
(f) X This is temporary vacancy caused by ---. Hence you are appointed full-time on purely temporary basis for a period of ----.
(g) X Your appointment is on Part time / clock hour basis only.
3. (i) You will be paid basic pay of Rs. **As per rules** per month in the scale indicated above. In case you are appointed for a period of more than one year, you shall earn annual increment.

(iii) Your appointment and salary shall be subject to approval by the Savitribai Phule University of Pune & Director of Technical Education/ Director of Medical Education & Research/ Director of Higher Education as the case may be.

(b) X You shall have to acquire the qualifications -- (M. Phil./ Ph.D; M.D./ M.S; M.D.S; M.E.etc.) as prescribed by the University/State Govt. or the Central Councils concerned within the --- period.
5. Your appointment is subject to the minimum number of students and the workload prescribed for the post.
